**Subject:** Nursing Home State Licensure Survey Findings for

A state nursing home licensure compliance survey was completed on July 24, 2018 at Christian Care Nursing Center pursuant to the Michigan Public Health Code, Act 368 of 1978, Part 201, Section 333.20155, which requires the Department to make at least one visit to each licensed health facility or agency every three years for the purpose of survey and evaluation. Pursuant to the Michigan Public Health Code Act 368 of 1978 and Part 217, Section 333.21711 requires that a nursing home is to be licensed.

The survey identified non-compliance with the following requirements:

**333.21765: Policies and procedures for Patient/Resident Bill of Rights.** During review of information provided to residents at the time of admission into the facility, it was noted the facility did not provide residents with a copy of their rights as enumerated in 333.20201 as required.

The non-compliance was corrected during the survey process when the facility added the list of resident rights as enumerated in 333.20201. The correction was verified on-site. No further action is necessary.

**333.21766: Written contract.** During review of the patient contract it was noted the contract did not contain information notifying the person executing the contract of the availability of hospice as required.

The non-compliance was corrected during the survey process when the facility added notification of hospice to the contract. This notification will be signed or initialed by the person executing the contract. The correction was verified on-site. No further action is necessary.

In summary, Christian Care Nursing Center is in compliance with the Michigan Public Health Code, Act 368 of 1978, Article 17 Facilities and Agencies, Part 201 General Provisions (MCL 333.20101 through 333.20211); Part 17 Nursing Homes (MCL 333.21701 through 333.21799e); and/or the Michigan Administrative Rules for Nursing Homes and Nursing Care Facilities (R 325.20101 through R 325.22004), as applicable.
