Subject: Nursing Home State Licensure Survey Findings for Promedica Skilled Nsg & Rehab Canton

An onsite state nursing home licensure survey was conducted on July 20, 2021, at Promedica Skilled Nsg & Rehab Canton pursuant to the Michigan Public Health Code, Act 368 of 1978, Part 201, Section 333.20155, which requires the department to make at least one visit to each licensed health facility or agency every 3 years for survey and evaluation for the purpose of licensure. A nursing home in Michigan is required to be licensed under the Michigan Public Health Code Act 368 of 1978 Part 217, Section 333.21711.

Findings: **333.20173a Covered facility; employees or applicants for employment; prohibitions; criminal history check; procedure; conditional employment or clinical privileges; knowingly providing false information as misdemeanor; prohibited use or dissemination of criminal history information as misdemeanor; review by licensing or regulatory department; conditions of continued employment; failure to conduct criminal history checks as misdemeanor; storage and retention of fingerprints; notification; electronic web-based system; definitions.** The facility did not conduct employee background checks for contracted staff members associated with their agency account within the miltcpartnership.org background check system as required by this statute. The facility corrected the non-compliance on July 20, 2021, when evidence was provided that contracted employees were registered in the facility's account of the miltcpartnership.org system as required.

Based on the virtual state licensure survey findings, Promedica Skilled Nsg & Rehab Canton is in substantial compliance with the Michigan Public Health Code, Act 368 of 1978, Article 17 Facilities and Agencies, Part 201 General Provisions (MCL 333.20101 through 333.20211); Part 17 Nursing Homes (MCL333.21701 through 333.21799e); and/or the Michigan Administrative Rules for Health Facilities or Agencies (R 325.45101 through R 325.45385).
