Subject: Nursing Home Licensure Survey Findings for SKLD Bloomfield Hills

Dear Cyle Pickett,

An on-site state nursing home licensure survey was conducted on March 16, 2022, at SKLD Bloomfield Hills, pursuant to the Michigan Public Health Code, Act 368 of 1978, Part 201, Section 333.20155, which requires the department to make at least one visit to each licensed health facility or agency every 3 years for survey and evaluation for the purpose of licensure. A nursing home in Michigan is required to be licensed under the Michigan Public Health Code Act 368 of 1978 Part 217, Section 333.21711.

At the time of the survey, the following non-compliance was found:

333.20173a Background Check

Not all contracted service providers had fingerprint results that associated their names with SKLD Bloomfield Hills. One individual was identified in an audit of files. On 6/16/2022 the facility submitted appropriate documentation, dated 3/25/2022, indicating that the identified individual was in the fingerprint database associated with SKLD Bloomfield Hills. Continuing compliance will be verified at the time of the next licensure survey.

R325.45385 Involuntary Discharge Procedures

The facility did not provide their procedures for involuntary (facility-initiated) discharge. There is no evidence that the facility is compliant with this requirement.

R 325.45139 Communicable disease screening, immunization, and mitigation for employees

The facility did not provide their written policies and procedures that addressed how their employees were screened for communicable disease; that outlined what was expected for

employee immunization and that how the facility mitigates the spread of infectious disease from employees to residents. There is no evidence that the facility is compliant with this requirement.

R 325.45379 Inventory of patient clothing and personal possessions

The facility was not keeping an inventory of clothing or personal possessions for all residents. At the time of the survey, the facility agreed to implement a system to ensure that an inventory was completed for each resident. This corrective action is accepted but actual compliance will be verified at the time of the next licensure survey.

In summary, SKLD Bloomfield Hills is not in compliance with the Michigan Public Health Code, Act 368 of 1978, Article 17 Facilities and Agencies, Part 201 General Provisions (MCL 333.20101 through 333.20211); Part 17 Nursing Homes (MCL 333.21701 through 333.21799e); and/or the Michigan Administrative Rules for Health Facilities or Agencies (R 325.45101 through R 325.45385), as applicable, until the issues associated with the issues as described above are resolved.
